- a) Gerald Thom Memorial Native Plant Garden
 - Jean Atkinson brought examples of colouring pages developed by Alex Work and Megan Bell

As well as 2 invasive species handouts.

Judy Brayden will be convening a meeting in October for all interested folks to consider the future maintenance of the Garden and the riparian area of Saywell Park, including any impacts of the weir construction.

It was mentioned that the General Contractor can be made responsible for the rehabilitation of any damage done to the garden during construction

- ii. Maureen Quested has agreed to liaise with Elizabeth Aitken of CVRD Parks on initiatives in Honeymoon Bay. Jim Deck would be willing to lead on Bald Mountain broom removal. A caution about previous partnerships being poorly organized has been noted.
- b) Celebrating Water Weir All Connected Festival Report Attached Further comments from Board
 - The value of dignitaries speaking may be more for the organizing group than for attendees.
 - ii. The heat on the day of the event had a huge impact on many activities eg. attendees didn't want to stand in the sun listening to speakers
 - iii. Recommendations on a future Signature Event should be dealt with through the Communications Committee
 - iv. Perhaps the Communications Committee can come up with a plan with regard to the signature event: timing; location; type (one main event or a number of stand-alone events) incorporating ideas generated at the strategic planning day
 - v. Statement of revenue and expenses was amended as honourariums were included twice See attached.
- c) Project 84,000 the 7 sheets of rubbings will be unrolled at River's Day with volunteers every 5' along the length of the panels along the river shore. It should be very impressive.

- a. Request for closure of fishing in the Upper Cowichan a letter, which was attached to the agenda, and composed jointly by Joe Saysell, Diana Gunderson and Judy Brayden has been sent to Minister Ralston with 20 signatures advocating for the closure.
- b. Salmon Fry Rescue Funds \$2000 was donated, but source is not clear. Treasurer's reports will be searched to determine where the funds came from and when, before any further action is taken. Funds have previously been used to make pole seines.
- c. Insurance Coverage Maureen will request a written outline of who exactly is covered under our insurance through the Stream Keepers and will update the list of volunteers if required.
- d. Strategic Planning debrief not available at this time.

- b. Proposal for CLRSS involvement in support of Developing Guidelines for Landowners to Conserve Riparian Forest Habitat for Bats in Coastal British Columbia. Time frame 4 years Project Goals:
 - to increase scientific understanding and public knowledge of bat populations and important riparian bat roosting habitats in the Cowichan Watershed
 - to promote the stewardship and securement of wildlife trees throughout the Cowichan watershed

Project Objectives:

- Species diversity – identifying confirmed list of local bat species

- Forest Habitat Use determine wildlife tree use by roosting bats
- First Nations Partnership and Capacity building incorporating traditional ecological and cultural knowledge
- Develop a bat habitat & public outreach/education program with focus on wildlife trees and bat roost trees
