**Stewardship Round Table**: Jim Deck, Christoph Steeger, Cam McCauley reported that there had been a speaker on trees and tree planting. It has been decided that Sequoias will not be used for replanting by forest companies at this time in BC.

  - Need for a creel census is particularly important gov't data
  - River is down to almost unsustainable levels of rainbow trout
  - Mike McCullough is Fisheries Biologist in charge of the Cowichan
  - Joe Saysell requested letters to Minister of Forests (Ralston) to extend upper river fishing closures
  - Regulations are published in April so letters can be written and sent now or November
  - Letters to Ministers Nathan Cullen, Bruce Ralston with cc's to Matt Elroy, Nathan's ass't, CWB, your MLA and MP
